19 February – Eurocarers Young Carers Working Group (EYCWG) meeting, Brussels

The EYCWG meeting will focus on planning and preparing for the involvement of young carers during the 3rd International Young Carers Conference 2020 (please see below). Please note that the Final Dissemination Event of the [Edy-Care project](#) will take place on the morning of the same day in Brussels (same venue). As you know, Edy-Care aims to empower teachers and other school staff in upper secondary education to recognise adolescent young carers (16-19 years old) in classes and maximize their learning opportunities, while ensuring their social inclusion. This Final Event will serve to present and

discuss the project's findings and next steps. You are all welcome to join the event.

17-18 March – Eurocarers Research Working Group meeting in Brussels

The Research meeting will seek to address the topic of the definition of informal care from a research perspective. It will also build on previous discussions regarding the development of good quality indicators in the field of care and caring. Finally, the meeting will, as always, allow to identify and discuss new funding opportunities for research on care and caring and present some latest news on our ongoing research programs. Detailed agenda and more information on how to register will be sent later on.

24 March – European Parliament Interest Group on Carers in Brussels

This Interest Group meeting will focus on the European Strategy on Carers, introduced by Eurocarers at the end of 2018, and on the progress made regarding its implementation at national and regional level. The programme for the event will include testimonials from carers in different European countries, followed by a presentation and discussion on recent/planned policy developments of relevance to carers.

29 April – In-country Policy Dialogue on Young Carers with Family Carers Ireland, Dublin, Ireland

In April 2020, Family Carers Ireland will organise a Young Carers Conference, funded by the Irish Government. The event is co-hosted by Eurocarers. European countries are at different stages of awareness and support for young carers. The presence of key speakers from countries other than Ireland will add an international perspective to the event and enable an enriching exchange of experiences and practices.

More details will be sent closer to the event.

27-28 May – Eurocarers' AGM 2020 and Policy Working Group, in Vila Nova de Gaia, Portugal

Our annual AGM will be co-hosted by our colleagues from [Cuidadores Portugal](#) and will take place in Vila Nova de Gaia on Wednesday 27 May (afternoon) and Thursday 28 May (full day). The programme will be designed to provide you with opportunities to share and build knowledge on issues relevant to your work, and we hope to welcome you in large numbers. The AGM will be followed by an In-country Policy Dialogue on Developing a policy environment suitable to Carers' needs, on Friday 29 May. A detailed agenda and more information on how to register will be sent later on.

6 October – Kick off of the European Carers Day

October – Eurocarers delegation to the Scottish Carers Parliament, Edinburgh, UK

Each year, Carers Scotland, on behalf of the Scottish Government and in partnership with the national carer organisations, organise a "Carers Parliament" allowing carers from across Scotland to gather and interact with their policy makers. The 8th edition of this very inspiring event should be held at the end of October and Eurocarers will once again arrange for the participation of a delegation of our member organisations. .

Eurocarers also has the pleasure to co-organise with the [Swedish Family Care Competence Centre](#) and

[Linnaeus University](#) the **3rd International Young Carers Conference in Brussels on 16-17 November 2020**

(Note that separate registration fees will apply to all participants to this conference). The Conference will reflect on the concrete actions required to enable young carers to reach their full potential. The need to “Identify, Support, and Listen to young carers” were the main recommendations identified by young carers themselves during the previous conference in Malmö in 2017 and this entails the participation of a multiplicity of stakeholders. Research, practices, policies and experiences around these main themes will therefore be shared in order to reinforce mutual learning among stakeholders and countries.
