## INTERNATIONAL

Eurocarers also has the pleasure to co-organise with the Swedish Family Care Competence Centre and Linnaeus University the 3rd International Young Carers Conference in Brussels on 16-17 November 2020 (Note that separate registration fees will apply to all participants to this conference). The Conference will reflect on the concrete actions required to enable young carers to reach their full potential. The need to "Identify, Support, and Listen to young carers" were the main recommendations identified by young carers themselves during the previous conference in Malmö in 2017 and this entails the participation of a multiplicity of stakeholders. Research, practices, policies and experiences around these main themes will therefore be shared in order to reinforce mutual learning among stakeholders and countries.
