

# Eurocarers Annual General Assembly 1-2 June 2022

Hybrid / Face to face + ZOOM

## **DRAFT MINUTES**

## **Quorum: Article 13 of the association's statutes states that:**

The deliberations are valid only if a quorum of at least 33% of the votes is present or represented. (35 out of our 38 full members have paid their fees in due time to be able to vote so, a minimum of 12 votes is required to comply with our rules). A total of 41 delegates, out of which 21 Full members (Tiers 1 and 2, present or represented) attended the AGM 2022.

The decisions are adopted by simple majority of the votes that are present or represented, except in the case of dissolution or an amendment of the present Articles of Association, which require a qualified two-thirds majority.

If a resolution is adopted regarding the election of the Chairperson, Vice-Chairpersons, Treasurer, Secretary or any other member of the Board, it is the person obtaining the highest number of votes that is elected.

## **General Assembly**

Welcome address by Sebastian Fischer, Board member and Chair of the AGM, on behalf of Sari Tervonen, Eurocarers President, who was unable to travel due to logistical issues at Heathrow airport.

## Verification of participants

Unlike in the last two years, this AGM was held in a hybrid format with some participants attending face-to-face while others joined online. As usual though, the identity of participants was checked via a two-pronged mechanism, i.e.:

- Personal invitations to the AGM 2022 followed by a pre-registration process all communications related to the meeting were sent exclusively to the email addresses provided by member organisations themselves; and
- The details to access the AGM, face to face or online, were sent only to those who had filled the registration form.

## Adoption of agenda<sup>1</sup>

Members were invited to submit their proposed motions or comments about the agenda to the secretariat by the 20<sup>th</sup> May 2022 and no submissions were received. The agenda was therefore unanimously adopted by the General Assembly, as circulated.

## Minutes and matters arising

• Minutes of the AGM held in Brussels on the 3<sup>rd</sup> June 2021 and Matters arising There were no matters arising from the previous meeting. The minutes of last year's AGM were therefore proposed by Frank Goodwin (Family Carers Ireland), seconded by Ana Ramovs (Anton Trstenjak Institute) and accepted by all.

#### Reports

Annual report and accounts 2021

#### Treasurer's report

Anita Vatland (Eurocarers Treasurer) gave an overview of her report (made available to member organisations a few weeks before the AGM) and of the financial situation of the Eurocarers network (AiSBL – Belgium) for the year 2021.

She explained that the financial situation of Eurocarers remains positive and sustainable in the foreseeable future. Our network's annual turnover in 2021 amounted to €463.194,26 and it built on 5 main sources of funding: the core grant accompanying our partnership agreement with the European Commission under the EaSI programme which was just renewed for the period 2022-2025 (55%), our EU-funded research projects (26%), our Membership fees (10%), our corporate sponsors (8%) as well as 'other' sources (1%). Anita also emphasised that our network has sadly lost a few members as a result of the financial difficulties arising from COVID-19 or due to changing policy priorities among civil society organisations.

<sup>&</sup>lt;sup>1</sup> The final agenda shall be decided upon by the General Assembly as soon as it opens on a majority of 2/3 of the members present or represented. For other decisions "decisions shall be taken by a simple majority of the votes present or represented, except in the case of dissolution or amendments to the Statutes which requires the qualified majority of 2/3" (Article 13 of Statutes)





As it stands, it comprises 70 members in 25 countries. Moreover, she confirmed the observations already discussed with the GA in the last two years that the level of membership seems to stagnate given that most of our new member organisations tend to join us at the full membership tier 2 and associate levels.

Anita concluded her intervention by thanking the network for its continuous commitment and support to our operations. During the Q&A session following her report, it was agreed that Eurocarers sponsors will be listed individually in future financial overviews so as to ensure clarity and transparency.

The Treasurer's report 2021 was approved by the full members organisations present or represented during the event (20 votes in favour and 1 abstention out of 35 full member organisations with voting rights at the date of AGM / Quorum: 12 votes).

#### Director's report

Stecy Yghemonos (Executive Director) then briefly outlined the deliverables produced by our network in 2021, as detailed in the Annual Report available on the Eurocarers website as of the 13<sup>th</sup> June 2022 (see <a href="here">here</a>). Our annual work programmes continue to be structured and implemented along four overarching objectives (and four work packages) defined in our partnership agreement with the European Commission (DG EMPL) under the Employment and Social Innovation (EaSI) programme. These include:

- Actions and recommendations to feed EU policy-making,
- 2. Bridge-building actions between EU level and national actors,
- 3. Awareness-raising and dissemination, and
- 4. Network organisation and management.

Accordingly, Stecy presented the activities implemented in 2021 in order to fulfill these four objectives:

#### Priority 1 - Actions and recommendations to feed EU policy-making

- Development of our **annual policy and advocacy action plan in light of relevant EU roadmaps and action plans**, in close collaboration with our Policy, Young Carers and Research working groups;
- Two **online meetings of the EP Interest Group on Carers** on the topics 'Towards an ambitious EU initiative on long-term care' (23<sup>rd</sup> February 2021) and 'COVID-19, Informal carers and the need for an EU Strategy on Care and Caring' (28<sup>th</sup> September 2021);
- One **online meeting of the Eurocarers Policy Working Group (EPWG)** on the 16<sup>th</sup> March, regarding recent policy developments of relevance to Eurocarers' mission (Europe's Beating Cancer Plan, EU Disability Strategy 2021-2030, EU Strategy on the Rights of the Child and European Child Guarantee, CoR consultation on a 'Future plan for care workers and care services' and Green Paper Ageing), the EPSR Action Plan and Eurocarers advocacy priorities in 2021-2022;
- One meeting of the Eurocarers Young Carers Working Group (EYCWG) held online on the 25<sup>th</sup> February to discuss programme, logistics and role to be played by the EYCWG during the Third International Young Carers Conference (see objective 3) as well as the message to be conveyed at the occasion of European Carers Day, on the 6 October 2021;
- The development of 15 Position papers and consultation responses;
- Active contribution to more than 180 relevant events and policy dialogues across Europe to promote the perspective of informal carers and inform policy agendas around care and caring; and



• Update of our review of the policy environment of relevance to care and caring throughout the EU, including via our overview table on the "Number of carers and existing support measures across the EU" as well as our series of 27 country profiles summarising policy developments of relevance to carers across Europe.

## Priority 2 - Bridge-building actions between EU level and national actors

- Co-organisation/contribution to four in-country policy dialogues on the situation and needs of carers, including:
- **5**<sup>th</sup> **Caring for carers event** on the topic "Balancing the Personal and Professional Life of Carers in the COVID-19 Era" (Athens, Greece 24<sup>th</sup> September 2021) organised by EPIONI, under the auspices of the Municipality of Vouliagmeni and in collaboration with the Hellenic Psychiatric Society.
- **3<sup>rd</sup> National Meeting of Informal Carers**, organised by the Portuguese Association of Informal Carers on the 5<sup>th</sup> November 2021 (which is Portuguese Carer Day) regarding the recently-created regulation of the Informal Caregiver Statute and its transposition at regional level.
- Meeting of the Finnish Family Care Parliament and 30-year Anniversary event of Carers Finland on the 6<sup>th</sup> October 2021 (European Carers Day), with the participation of Ms. Krista Kiuru, Minister of Family Affairs and Social Services, MPs Merja Kyllönen and Mia Laiho, as well as experts of the Central Organisation of Finnish Trade Unions, Finnish Confederation of Professionals, University of Tampere and Department of Health and Welfare.
- **23**<sup>rd</sup> **Swedish Carers Parliament meeting** organised by Carers Sweden and held on the 9-10 November 2021 (as a hybrid event) at the Karlstad Congress Culture Centre. The event focused on "Informal carers across time" and allowed to shed light on various dimensions of care, including the (mental) health of carers, men in care, carers' experiences during the pandemic, palliative care or the future of care.
- Knowledge-sharing webinar on carers' access to adequate income (income replacement, reintegration in employment, etc.), pension rights as well as other income-related issues (for example financial toxicity of care), held on the 26<sup>th</sup> October 2021.
- Four new briefings, including on the EC/EP proposal on an EU Care Strategy and what we expect from it (October 2021), ICT and Care, with a section on the factors influencing carers' use of ICT (November 2021), Gender Equality and care (December 2021); and our analysis of the EU Recovery and Resilience Facility (December 2021).
- Ad-hoc partnerships and collaborations with other CSOs (AGE, WHO, OECD, etc.)

## **Priority 3 - Awareness-raising and dissemination**

- Second EU-wide 'European Carers Day (ECD) campaign on the 6<sup>th</sup> October 2021, on the topic "Identifying, listening to and supporting young carers". The campaign entailed the development of a campaign visual and messages, dedicated website with first-hand testimonials by young carers (<a href="www.carersday.eu">www.carersday.eu</a>), infographics, social media accounts and campaign poster (available in 11 languages).
- Restructuring of the Eurocarers website (<a href="www.eurocarers.org">www.eurocarers.org</a>) as a user-friendly information hub on care, carers and caring, with updated info on the situation and needs of carers in Europe, EU/national policies with a bearing on carers' life, Eurocarers' positions, promising promises as well as practical advice (such as toolkits) to help carers in their daily caregiving activities;
- 8 Press releases
- 8 editions of the newsletter disseminated among more than 200 readers
- Contribution to 3 articles in the national media and 3 podcasts





- Co-organisation and co-hosting of the **Third International Young Carers Conference** held online on the 3-6 May 2021 with the participation of more than 300 participants (Researchers, practitioners, policy-makers and young carers) from 26 countries.
- Two online meetings of the Eurocarers Research Working Group (ERWG) to discuss the Irish study on "Models of Family Carer Support During Covid-19", the InCare project (also funded through the EaSI programme) and the SPC/EC 2021 Long-Term Care in Europe report (on the 16<sup>th</sup> June) as well as respective research activities and learnings, the EIGE-funded study regarding the Gender gaps in unpaid care, the Results of Me-We project on young carers, the cost of informal care in Sweden, the Danish Construct of care, Morbidity among Finnish carers, the experiences of older carers, online training for carers, the impact of COVID on carers and predictors of Digital Support Services Use among carers (26<sup>th</sup> November 2021).
- Annual report 2020, published in June 2021.

#### **Priority 4 - Network organisation and management**

- Development of our **Network Development Strategy for the period 2022-2025** in close collaboration with our Board and General Assembly as well as update of our **Risk Assessment table**, **Eurocarers employment Policy** (to reflect the new structure of our secretariat) and **ethical guidelines**, which govern our relationships with the private sector.
- 5 online meetings of the Eurocarers Board;
- Eurocarers Annual General Meeting, held online on the 3rd June 2021;
- 2 knowledge-sharing sessions on key learnings from the Eurocarers Survey on COVID-19 and carers as well as on Eurocarers' planned action around European Carers Day 2021 (on the topic of young carers), held in the margins of our AGM 2021.

The General Assembly unanimously welcomed these positive developments and formally discharged the Board of Directors for fulfilling their mandate up to the 31<sup>st</sup> December 2021 (20 votes in favour and 1 abstention out of 35 full member organisations with voting rights at the date of AGM / Quorum: 12 votes).

## **Way Forward**

Stecy then highlighted the Secretariat and Board's plans regarding our Work Programme and Budget 2023. He explained that the EaSI call for proposals has already been published by the commission (with a deadline for submission on the 23<sup>rd</sup> June) and that the structure of our proposal will largely remain similar to our existing model. As always, he invited member organisations to express their views on the type of activities that they would like to see organised in the coming months/years and the topics that they would like to explore through the network. Members can contact the secretariat with any suggestions they may have about these aspects. Stecy also reminded the GA that our work programme should ultimately serve the collective interests of our organisation. When it comes to our planned budget for the year, the implicit agreement with the EC is that it should remain at a similar level compared to previous years.

Following the Director's presentation, the proposed approach for our structure, budget and key activities in 2023 (part of which will be funded through the EaSI programme) were also unanimously endorsed by the General Assembly.



## **Membership**

**Sebastian** pointed out that eight member organisations (1 full member tier I, 3 full members tier II, 3 Associates and 1 observer) have joined our network in the last two years. These are:

Since not all were able to introduce themselves in previous meetings, those in attendance were invited to say a few words about their work and the nature of their interest in Eurocarers' activities.

## **Election**

Sebastian reminded the General Assembly that, according to Art. 15 of our internal rules, each full member organisation is entitled to nominate one person to serve on the Board. Membership of the Board is organised according to three panels – directors nominated by tier 1 members; directors nominated by tier 2 members and a third 'management and technical' panel (i.e. up to four additional individuals to complement the Board's management and technical skills).

The number of 'tier 1' vacancies is equivalent to one third (rounded up to the nearest number) of the number of organisations in that category who have paid their membership fee by the required date. The number of vacancies in the 'tier 2' panel is equivalent to one tenth of the number of organisations in that category who have paid their membership fee by the required date.

At the date of the AGM 2022, 11 Full members Tier I and 24 Full Members Tier II had paid their fees. Consequently, four seats are available on the 'Tier I' panel, three of which are already occupied by Sari Tervonen (Central Association of Carers in Finland and Eurocarers President), Anita Vatland (Norwegian National Alliance for Carers and Eurocarers Treasurer) and Sebastian Fischer (Voice of Carers Across Lothian, Scotland). Three seats are also available on the 'Tier II' panel, two of which are occupied by Sara Santini (INRCA) and Bruno Alves (Cuidadores Portugal). This means that two Board seats remained to be filled (1 in tier 1 and 1 in tier 2).



A total number of four nominations were submitted by the deadline set by the Board, in accordance with our rules. These are:

#### Tier I – 1 seat available:

- Henk Nies, member of the VILANS Board of directors and professor of Care organization and policy at the Free University of Amsterdam.

## Tier II - 1 seat available:

- Andreas Hoff, Deputy Convenor of the German Beirat für Vereinbarkeit von Pflege und Beruf (Germany)
- Lucie Freyssignac, FNAAF (France), and
- Stavros Terzakis, President of EPIONI (Greece).

In accordance with articles 15.2 and 15.3 of our internal rules, no vote was required for the election of the Tier I Board member since the number of nominations received by the Secretariat is equal to the number of vacancies for that category. Henk Nies was therefore elected as Board member Tier I.

As for the Tier II category, 21 members present or represented cast their vote (out of 35 full member organisations with voting rights at the date of AGM / Quorum: 12 votes), as follows:

Henk Nies and Andreas Hoff were consequently appointed as Board members in the Tier I and Tier II categories, respectively. Sebastian warmly congratulated them on behalf of the network and asked our secretariat to communicate these changes in the governance structure of our organisation to the competent authorities (Official Journal, business registry, bank, etc.), as required by Belgian law.

#### AOB

No items were added to the AOB section of the agenda.

Sebastian Fischer and Stecy Yghemonos thanked participants for their active and continuous participation in our activities and dialogues. This concluded the Eurocarers AGM 2022.
