#### Dear readers,

Welcome to this first edition of our newsletter in 2018. Last year was marked by the ambitious EC proposal for a Directive on Work-Life Balance for Parents and Carers, which has been at the core of our advocacy efforts. This important political process which could be a new positive milestone in the development of carer-friendly societies is far from over and the momentum now lies at national level since the European Parliament and the EPSCO Council are due to support or discard the proposal by the end of this year. This is the reason why we are working closely with our member organisations to contact individual MEPs and relevant authorities (national and regional parliaments, ministries, etc.) and convince them that supporting carers makes social and economic sense and that the proposed legislative package should therefore be supported.

This important agenda should not overshadow the launch of six promising new EU-funded projects, focusing on young carers, ICT-based solution for care and integrated care, which will help us maintain the existing momentum and further inform the development of evidence-based policies targeted at carers in Europe. To do so, the secretariat has been reinforced through the recruitment of three new experienced colleagues:

- Mariana Vicente is our new Senior Project Officer. Mariana is a trained psychologist. She has worked as a Senior Health Officer at the Portuguese Ministry of Health for almost a decade and more recently was a Project Manager at the European AIDS Treatment Group. Mariana will lead our work on integrated care services and the implementation of the Social Pillar's objectives on the provision of equitable health, social and long-term care. Her input will build on two of our new projects, on ICT-based solutions for good quality care; which she will coordinate.
- Divier Jacqmain is our new Communication Officer (part-time). Olivier has wide-ranging experience and expertise in the fields of design, editing, campaigning, online communication and publications. He will be a great asset for the development of our future communication strategy and the coordination of our messaging at all levels. He is no stranger to our work since he has been one of the driving forces behind our publications in the last couple of years.
- » <u>Riika Lempiainen</u> is our new Administration and Finance Officer. A Finnish national, she holds a Master's Degree in history and economics. Her extensive experience in finance, human resources management and office administration will prove useful in the context of our new development phase.

Needless to say that our colleagues Claire Champeix and Francesca Centola are still fully committed to our work. As a Policy Officer, Claire will contribute to all of our advocacy activities with a specific focus on employment, social inclusion and poverty. Francesca is now a Project Officer and she will coordinate our Young Carers Working Group and lead our work in the two new projects aiming to improve the resilience, mental health and well-being of Adolescent Young Carers and mitigate the negative influence of informal care on their educational and professional prospects.

### A more united, stronger and more democratic Union: Joint Declaration on the EU's legislative priorities for 2018-2019

European Commission President Jean-Claude Juncker signed today the new Joint Declaration on the EU's legislative priorities for 2018-2019, alongside President of the European Parliament, Antonio Tajani



and holder of the rotating Council Presidency and Prime Minister of Estonia, Jüri Ratas.

The Declaration sets out 31 new legislative proposals tabled by the Commission which will be given priority treatment by the Parliament and Council for adoption or substantial progress by the time of the European Parliament elections in 2019.



Nearly 37,000 people in 33 European countries (28 EU Member States and 5 candidate countries) were interviewed in the last quarter of 2016 for the fourth wave of the European Quality of Life Survey. This overview report presents the findings for the EU Member States. It uses information from previous survey rounds, as well as other research, to look at trends in quality of life against a background of the changing social and economic profile of European societies. Ten years after the global economic crisis, it examines well-being and quality of life broadly, to include quality of society and public services.

#### The Netherlands: Carers Survey 2016


The Netherlands Institute for Social Research (SCP) carried out a survey in 2016 on informal care. 7,000 Dutch citizens (helpers and non-helpers) were surveyed. The survey demonstrated that 32% of the respondents help out of which 8,5% experience a severe burden. Has this evolved between 2014 and 2016?

When it comes to living situations of carers, the dynamic and growing body of research has substantial practical implications. To strengthen the voice of carers in science, representation of interests and participation in research processes is of crucial importance. Against this background members and partners of the German carers advocacy wir pflegen established a research working group in autumn 2017.
