



Hence, the idea to have a single care hub, with the aim to ensure social inclusion of families otherwise isolated and more coordinated provision of different services.

News from Norway – Carers Survey 2016

Pårørendealliansen (Norwegian Alliance for Carers) did the first official Carer-survey after getting approved from the Ministry of Health. It is estimated that 800.000 people of a population of 5.2 million are caring for 1 or more old, sick or disabled person. 1 out of 6 persons is a carer. We formed 23 questions + 5 demographic information options and sent out via social media and emails. We got 3.127 answers and over 4.000 comments!
