Dear readers,

Welcome to the first edition of our newsletter in 2017. Last year ended on a bit of a cliffhanger, with a very promising proposal tabled by the European Commission on a "New start to address the challenges of work-life balance faced by working families" and a new initiative on an EU Pillar of Social Rights. These developments, if approved by the Council, have the potential to create an even bigger momentum for our message: informal care is an asset for Europe and should be supported but informal care should remain a choice and carers should therefore be able to rely on good-quality professional care alternatives.

The work-life balance proposal includes very strong arguments in favour of carers and goes as far as to suggest the creation of an EU carer leave while the Pillar of Social rights clearly acknowledges the burden of care and the obstacles that informal care responsibilities generate on the road to employment. At the time of this editorial though and as a result of a two-stage consultation with social partners, it seems that some of the flagship features put forward by the EC (such as the EU carer leave) might finally be watered down in the final proposals to be published in the coming weeks. Nevertheless, we remain convinced that both the work-life balance initiative and the Pillar of Social Rights offer a great backdrop for our work in 2017 and beyond.

DG Employment, Social Affairs and Inclusion – our main partner in the European Commission - has already announced that unemployment and youth will be the two main priorities for the coming period and we will therefore continue to emphasise the challenges faced by working carers and young (adult) carers. As always, we look forward to collaborating with you on these topics and more.

To conclude, I would like to draw your attention to the article that briefly presents our planned capacity-building and advocacy activities for this year (see News from the Network section). These activities aim to meet your needs and support your daily work so, as always, your participation will be most welcome. We would therefore be very grateful if you could pencil your diary and let us know whether you want to attend - or even host – one of these events.

Health in the Annual Growth Survey 2017



On December 8, the Council met in its Employment, Social Policy, Health and Consumer Affairs formation (EPSCO). The debate revolved around three questions posed by the Presidency, namely: whether the European Semester and the Annual Growth Survey should be the subject of debate in the Health part of future meetings of the Council (EPSCO) in order for it to be better involved in the European Semester process; whether the Working Party on Public Health at Senior Level should be instructed to review in what way an increased involvement of the Council (EPSCO) could contribute to improve the European Semester process; and how the Annual Growth Survey could best be used to ensure that health systems are fit for the future.

EU's legislative priorities for 2017

On 13 December 2016, the Council approved the EU's legislative priorities for 2017 as agreed beforehand with the European Parliament and the

Commission. This will help the three EU institutions to pool their efforts and to ensure substantial progress in fields where they are most needed. A joint declaration setting out the EU priorities will be signed by the Slovak Prime Minister Robert Fico, the President of the Parliament, Martin Schulz, and the President of the Commission, Jean-Claude Juncker later the same day.

In this environment, there is a clear need for health services delivery that is proactive rather than reactive; comprehensive and continuous rather than episodic and disease-specific; and founded on lasting patient—provider relationships rather than incidental, provider-led care.

On 26 January 2017, Alice de Boer, a researcher at the Netherlands Institute for Social Research/ SCP in The Hague, delivered her inaugural lecture as professor of an endowed chair in Social Inequality and Informal Help in the Faculty of Social Sciences at VU University Amsterdam.

Lots of people in the Netherlands are currently providing informal help: there are more than four million informal carers and almost a million volunteers providing care and support. A good deal of concern has been expressed in the public debate about this unpaid help and about the specific groups who provide it.

Research conducted by the IARS International Institute indicates that BME young carers constitute one of the most, if not the most, marginalised and neglected groups by policy makers, the current administration and independent funders and educators. IARS's work forms part of the EU funded Care to Work project and the findings are now backed up by the December Children's Commissioner study on the current services provided to young carers by local authorities.

In the Malopolska Region, the number people who are dependent because of age and disability increases. Already, one out of five Malopolska citizens is the caregiver of an elderly person, and in a few years it is estimated that 100 people of working age will support 58 dependents. In addition, care services and assistants are required for people with serious disabilities, who currently represent 12% of the Malopolska population. This diagnosis highlights the scale of the needs, and thus the scale of the challenges that lie ahead.
