INTRODUCTION

The European Parliament Interest Group on Carers was founded in 2007 by MEPs Kathy Sinnott and Marian Harkin, supported by MEPs Anna Zaborska and Magda Kosane Kovacs, at the initiative of Eurocarers.

The Groups original mission was

- 1 to provide a forum for debate: to discuss and debate European policy development for their impact on carers and their interests
- to initiate policy action: to take initiatives that can lead to/influence EU policy initiatives, i.e. Parliamentary Questions, amending policy proposals, discussions with the relevant policy makers, host events/hearings on carers and their interests.

During its first ten years, some 35 meetings were organised in the European Parliament, attended by MEPs, representatives of the European Commission, Council of Ministers and stakeholders active in the social and/or health arena, including Eurocarers' members.

Meetings usually address current EU policy developments with a potential impact on carers as well as relevant topics which are not yet on the EU policy agenda.

The meeting programme usually consists of an introduction by a European Commission official who is involved in the issue under discussion, followed by commentaries from relevant stakeholders and experts.

Not only do these meetings provide an opportunity to meet and engage with MEPs who are interested in carers and their issues; they also enable Eurocarers and its members to exchange information and experiences with representatives from other European social and health and research organisations; in other words, they also function as a means of building partnerships and raising awareness.

Meanwhile the Group has changed its name and is now called the European Parliament Informal Carers Interest Group, in order to make the distinction between formal and informal care.

Its mission statement is as follows:

The Interest Group on Carers aims to critically monitor and analyse EU policy development for its impact on carers and to propose and advocate concrete action in order to improve the day-to-day situation for Europe's many carers, working in close partnership with relevant stakeholders.

THE FUTURE

It is fair to say that the Interest Group has made an active contribution towards the inclusion of informal carers and their issues in EU policy development. Examples include the increased attention for informal carers in the current discussions on work-life balance, the development of integrated community-based long term care services (recognising the role and contribution of carers) and the need to take better account of carers in the future of social protection systems.

However, the work of the Group is by no means completed. Much remains to be done to develop a policy environment that recognises, supports and empowers informal carers. According to recent EU research, informal carers across the EU currently provide over 80% of all care, with women providing approximately two thirds of care mainly as daughters (in law) and wives/partners. If not adequately supported, caring can have challenging consequences in a variety of ways: for the (physical and mental) health and well-being of carers, their capacity to balance paid work with care responsibilities, their financial situation, their social integration as well as their access to employment

and education. Yet, there are many EU policy domains which – directly or indirectly – impact on carers and which take no or insufficient account of carers.

Recent initiatives – such as the EC proposal for an EU pillar of social rights – provide a new favourable context and offer great potential for the work of our network and the development of 'carer-friendly' societies.

The main focus areas of the Group will therefore be:

- Caring as a barrier to social inclusion and employment;
- Young carers;
- Informal care in the future of care and caring in Europe (e.g. health systems)

Eurocarers will be delighted to continue its role as coordinator of the Informal Carers Interest Group.
