Professional summary and supporting statement:

I have over 20 years' experience working in the charity and not for profit sector. I am an experienced programme development and delivery manager and Director of National Programmes and Innovation. Responsible for high profile local and national programmes of work driving change for vulnerable children and young people; I have specialist knowledge of the young carers sector both nationally across England and internationally. I have developed, delivered and evaluated both national and local strategic and operational programmes driving change. Combining strategic thinking with programme delivery; ensuring the voices and opinions of young people are the foundation of programme and business development and are the drivers of systemic impact and policy change.

I have an extensive knowledge and understanding of the Health and Social care policy and practice landscape, including in relation to children whose parents have a mental illness, and families where there are young carers. I have shaped and modelled services and campaigns, working with partners across the sector and within the UK Government influencing national and local decision makers across England. Including the duties outlined in the Care Act 2014, the Children and families Act 2014, the Health and Care Act 2022. Having worked in the sector for over 20 years to ensure a collective voice influences effective change for vulnerable families.

My skills are grounded in social work, with extensive knowledge of the health and social care landscape and at both local and national level and when working with local partner organisations. I have expertise and knowledge of Parliamentary business and the mechanisms involved in developing legislation, policy and statutory guidance. I have built and managed trusted relationships with Government Departments to influence change; including the Department of Health and Social Care Carers Policy Team and informed the response to Covid Guidelines and the Department for Education to influence the inclusion of young carers in the national school census in 2023. I have worked with the Ministry of Defence Armed Forces Community Covenant to ensure recognition of young carers were included in the review of the needs of UK Armed Forces Families and Veterans. I have built and managed relationships with a number of Government All Party Parliamentary Groups to influence their thinking and priorities regarding unpaid carers; including the APPGs for HIV / AIDS, Carers, young carers and young adult carers, APPG for Children and Refugee and Migrant families. This has ensured I have experience and expertise and knowledge of Parliamentary ways of working and the mechanisms involved in developing legislation, policy and statutory guidance.

I have published research, policy and practice guidelines and influenced both national and regional development of multi-sector services. I hold personal positions and membership on a number of national strategic groups; including the Department of Health and Social Care Unpaid Carers Strategic Oversight Group, NHS England's Commitment to Carers Oversight Group, the Associate Directors of Adult Social Services (ADASS) regional carers oversight group, the All Party Parliamentary Group (APPG) Carers and the APPG young carers and young adult carers.

I am passionate about the voices of children and their families driving programme development, policy and systems change and increasing their visibility within the systems. I have lead on the design and delivery of effective and engaging participation activities recognising young people and their families are the experts in their own lives and need to be engaged in influencing and informed about decisions which affect them. For 20 years I lead on the planning and safe delivery of the 'Voice Zone' activities at the National Young Carers Festival in England organised in partnership by The Children's Society and YMCA Fairthorne Group in order to engage the voices of young carers in policy change; including the rights and duties in the Care Act 2014 and Children and Families Act 2014.

I have developed successful programmes of work tackling the root causes of issues relating to adverse childhood experiences. Including isolation, sexual, criminal and financial exploitation, county lines, coercion and grooming. Responsible for the safeguarding of children and implementing safeguarding and child protection procedures and policies. I have published Government endorsed documents and resources, enabling practitioners to effectively identify the multiple vulnerabilities of young carers and implement effective whole family, whole council, multi-agency support.

I developed the national Young Carers in Schools Programme delivered in partnership by Carers Trust and The Childrens Society. Which provides schools with the tools and resources they need to embed a whole school approach to recognising, understanding and meeting the needs of young carers. To date this programme has engaged with over 1000 schools, including engagement with Multi-Academy Trusts, private schools, Local Authority funded schools. Pupil Referral Units, Colleges and further and higher education institutions, across England who are showing increased positive outcomes for the young carers, their peers and the school staff.

I'm an experienced and approachable team player and I have extensive experience of managing teams and individuals, project and programme management. I have experience of managing conflict within teams, capability and disciplinary processes as well as professional development and enabling multi-disciplinary teams to thrive. I have developed opportunities for volunteers including management and co-ordination and safe record keeping. I have managed social work students from the Universities of Winchester, Southampton and Portsmouth and provided Practice Education supervision, International fellows on placement from Japan and Kenya and supported young carers themselves into internship and apprenticeship opportunities. I have previously been commissioned by the International Federation of Social Work and Commonwealth Organisation of Social Work to deliver training, consultancy and

development of services overseas regarding the needs of young carers internationally in Kenya and East Africa, Canada, Japan and Europe.

I have been responsible for writing the Business Plans for individual programmes of work as well as writing the organisational strategy for a large national charity working across England and Wales as part of the Senior Leadership Team. Alongside this I wrote the organisational Anti-Racist statement of intent and commitment to be an inclusive organisation.

I have experience of budget setting and financial management of programmes; including large national programmes with small and restricted budgets and regional programmes holding multiple budgets and contracts of work. I have experience of successful bid writing for both smaller and large multi-million funds and understand commissioning cycles and processes. Managing relationships with commissioning managers and reporting including outcomes and finance management.

I have excellent interpersonal skills and self-awareness and am approachable. I am able to build strong and trusted relationships with a range of stakeholders. I am able to build inclusive relationships with young people, carers and families accessing support services and at community events and outreach, including the particularly vulnerable to enable effective engagement. I have experience of building and maintaining long-term relationships and alliances with Commissioners, multi-agency sector organisations and partners. Experience of working with statutory agencies including NHS Englands regional carers leads, ICS's (previously CCG's), Local authority Adults and Childrens Services, Health Providers, Schools and Education settings including further and higher education and partnership working with other charities.

I have excellent IT skills including using databases, excel, Publisher and Powerpoint, Microsoft Teams and Zoom for meeting and training, Mosaic and Lamplight case management system, website maintenance, development and content writing and Cascade people management and personnel systems, eCRM systems, finance management and budgeting tools including MyFinance and MyBudget.

I am a self-starter, I am able to juggle busy workloads and work at pace, I am able to recognize and respond to opportunities as they appear and plan well to manage conflicting priorities. Using organisational planning tools such as Gantt charts, timelines and managing teams diaries and events calendars. I am able to work flexibly across the week and travel to ensure attendance at all required events and meetings and opportunities to develop services and build strong partnerships. I have the ability to manage own workload, am self-motivating and overall passionate about supporting and developing support and services and influencing change for children and families where there are young carers.

as being young carers including those in the youth justice and youth offending system and those on the edge of care.

Ensuring policy development work to be grounded in the voices of young carers and informing tools for multi-agency practitioners to effectively identify and support vulnerable children and prevent them from taking on inappropriate caring responsibilities. This role included the writing and publication of Government funded and endorsed online resources such as the Young Carers Whole Family Pathway, Young Carers Know your Rights Pack, Refugee Family Carers Toolkit, Culturally Inclusive Practice Toolkit to enable services to ensure inclusivity in their identification and support to families. In addition this role included managing a number of national programmes developing services for young carers in families affected by stigmatised illness including HIV, Substance Misuse, Mental illness and poor mental health, Migrant, Refugee and Asylum Seeking families affected by the impacts of forced migration, PTSD, War and Torture. Underpinning all of this work the voices and opinions of the young carers themselves were embedded through innovative and fun participation, consultation and engagement activities.
